

1. Introduction

1.1 You may access most areas of our site www.petregaz.com (“Website”) without registering your details with us. Certain areas of the Website may only be available to you if you register with us.

1.2 By accessing any part of the Website, you shall be deemed to have accepted these Terms of Use in full. If you do not accept these Terms of Use in full, you must leave the Website immediately.

2. Licence

2.1 You are permitted to print and download extracts from the Website for your own individual use on the following basis:

1. no documents or related graphics on the Website are modified in any way;
2. no graphics on the Website are used separately from the corresponding text;
and
3. Petregaz’s copyright and trade mark notices and this permission notice appear in all copies.
